

# 2009 Warren County Fair Commercial Exhibitor Contract

Commercial Spaces at the Warren County Fair rent for \$50 each. Space sizes in the Commercial Building or on the outside Commercial Area are 10'x10'.

## Rules and Regulations:

1. Commercial Space to be set up Saturday June 27<sup>th</sup> or Sunday June 28<sup>th</sup> between the hours of 9 a.m. to 4 p.m. If another time is needed arrangements need to be made in advance with Commercial Building Supervisor.
2. Exhibits to be set up and operational Sunday June 28<sup>th</sup> and be open Sunday, Tuesday and Wednesday from 4 p.m. to 10 p.m. and Thursday, Friday and Saturday from 10 a.m. to 10 p.m.
3. Tear down and clean up will after 12 p.m. on Saturday or Sunday from 9 a.m. to noon. There will be no vehicles allowed on grounds before the close of fair on Saturday for removal of Commercial Exhibits.
4. Exhibits must be contained within their designated space. No solicitations are to be made outside the designated space.
5. Noise levels must be kept at a level which will not interfere with other exhibitors. Obstructions or potential hazards will not be tolerated in exhibit and adjoining areas.
6. No selling of knives, potentially dangerous instruments, fire crackers, or drug-related paraphernalia is allowed. Exhibits which are deemed offensive, lewd, or in poor taste may be closed at the discretion of the fair management.
7. Vendor must supply display tables. Inside space and some outside spaces are supplied with electricity. Extension cords are not supplied from electrical source to booth.
8. Building will be locked every evening from 10 p.m. to 9:30 a.m. All replacement of booth merchandise must be made prior to 10 a.m. each day, or by making arraignments with Commercial Building Supervisor. Absolutely no vehicles will be allowed in the exhibit area except for display between 10 a.m. and 12 p.m.
9. All commercial announcements on the public address system will be subject to the rules and regulations of the Fair Board.
10. Money raffles, games or chance with money pay-offs or awards, cash lotteries or any other gambling activities prohibited by State law shall be prohibited on or about the Fairgrounds.
11. If exhibitor is selling any kind of merchandise a City Merchant license must be obtained from the City of Warrenton.
12. Political candidates may display campaign literature in their respective booths.
13. All animals used in the exhibit must be removed from the fairgrounds at the close of exhibit hours each day.
14. The Fair Board of the Warren County Fair reserves the right to interpret the above rules and regulations and determine all matters pertinent thereto; also the right to amend and or add such rules as may be deemed necessary. Violation of any of the regulations shall cause forfeiture of all privileges, deposits, contracts, and right of participation by the violator.
15. There will be not distribution of any kind of advertising material outside assigned booth area.

## Liability of Exhibitors

In no case shall the officers, board members or association members of the Warren County Fair be held responsible for any loss, damage, injury, theft, death, or from any other cause of any character, to any property while the same is on the Fairgrounds. Officers, board members or association members of the Warren County Fair Association hereby assume no responsibility either as a bailee or otherwise for any property brought upon said fairgrounds and it shall be at the Exhibitor's risk. Exhibitors must provide a certificate of insurance (\$1 million liability coverage) prior to fair date listed additional insured Warren County Fair Association.
