1. Open to all Missouri 4-H and FFA members age 21 and under as of show date. Exhibitor can enter only one animal in the steer show and two animals in the heifer show.
2. All exhibitors must comply with the general rules and regulations and Animal Health Requirements for Exhibition at the Warren Co. Fair.
3. All Health papers are to be delivered to the Superintendents upon arrival of steers and heifers.
4. Each Exhibitor will be expected to keep their pens and areas clean.
5. Abuse of animals will not be tolerated. Should an abuse be observed toward an animal, either in the barn or in the show ring, superintendents have the authority to eliminate show animal and exhibitor from the show. Entry fee will not be refunded.
6. No assistance in showing animals will be allowed in classes unless approved by the show officials.
7. Arrival time at the fairgrounds is 11:00 a.m. to 5:00 p.m., Friday July 3rd. Weigh-in 3:00 to 5:00 p.m. All Warren County Exhibitors enter between 11:00 a.m. to 1:00 p.m.
8. Steer show time will be 6:00 p.m. Heifer show immediately following the Steer show.
9. Nomination fee of \$10.00 per animal, payable in advance, is required to enter a class. All money collected will be used for 100% payback.
10. Out of county entries and payment must be in advance and be postmarked by Friday, June 5th, 2009.

12. Release date and time for the Jackpot Steer & Heifer Show is Friday, July 3rd at 9:30 p.m. All Out-of-County and Non-Auction steers must be off grounds by 12:00 a.m.
13. No trucks or trailers will be permitted to park behind barns except while loading and unloading. After unloading, livestock trailers may park in restricted parking area. Any vehicle found in the restricted areas without the proper stickers are subject to towing at owner's expense.
14. No grooming chutes will be allowed in the show barns.
15. Steer classes will be broken according to steer weight. Breed & age will divide heifers. Official weigh-in will begin as stated in Item 7.
16. Errors in premium payments not reported to Warren County Cattlemen's Association by July 17, 2009 will stand as paid.

17. No dogs are allowed on the Fairgrounds.
18. Failure to comply with the above regulations or specie regulations will result in the forfeiture of any or all premiums won.
19. Animals must be registered in the exhibitor's name---No farm names will be accepted. ***Animals must be shown by exhibitor they are entered and registered under!***
20. Heifers born between September 1, 2007 and October 31, 2008 are eligible to show. Steers must have been born in 2008.
21. Stalls will be assigned upon arrival. If a calf is scratched, that stall space will be forfeited with no refund of money.
22. The Fair Board, Warren County Cattlemen's Association, or Show Personnel are responsible for accidents.
23. This is a youth show, therefore, we expect the ethics of 4-H and FFA to be endorsed. ***No drug use will be tolerated! Violation will result in expulsion from show and loss of entry fees.***
